- 2. The legal basis for processing Your personal data is constituted by realization of contract, signed between You and the Data Administrator (thereafter **Contract**), for issuing and execution of which processing of Your personal data is necessary- article 6, sect. 1, letter b RODO, also based on the legally justified interest of the Data Administrator (article 6, sect. 1, letter f, RODO) in form of commercial correspondence, and conducting direct marketing activities.
- 3. Your personal data is processed for the following reasons:
 - Issuing and realization of contract, signed between You and Data Administrator

- Conducting commercial correspondence
- seeking redress on the grounds of the Civil Code, should it appear
